Information for overnight guests about the spa fee State capital Wiesbaden

The state capital Wiesbaden is a state-recognized spa.

It charges to partially cover the costs of creating, expanding and Maintenance of the facilities provided for spa and recreational purposes (spa facilities) and for the events held for these purposes a resort fee all year round. This is a public tax.

The basis for this is the statute on the collection of a spa fee in the area State capital Wiesbaden (spa tax statute).

All adult non-residents living in the survey area are required to pay contributions take accommodation for a fee.

The obligation to pay a contribution begins on the day of arrival and ends on the day of departure. Both days count as one day when calculating the spa fee.

The spa fee is 5.00 euros per day of stay and per person from February 1, 2024. For severely disabled people with a severely disabled person's pass, the spa fee is reduced by 50%. From February 1, 2024, people accompanying severely disabled people, physically disabled people, blind people and sick people who require constant accompaniment will be exempt from paying contributions, provided that the need for constant accompaniment can be proven.

The spa fee is charged for the duration of each uninterrupted stay in a calendar year at the rate mentioned above, but at most up to a total length of stay of 30 days in the calendar year.

The following are exempt from the obligation to pay the spa fee:

- · Persons who are patients in hospitals
- · Pupils and students on school or study trips,
- · Pupils who are in Wiesbaden to take part in block lessons at vocational,
- · Persons who take part in leisure activities, trips, camps, conferences, courses and courses that are carried out by recognized independent youth welfare providers, during their duration,
- Persons who are staying in Wiesbaden for the purpose of participating in seminars in accordance with Section 4 Paragraph 3 of the Federal Voluntary Service Act or in further training, courses and similar events or to carry out their duties as part of the Federal Voluntary Service, for the duration of these,
- · Persons who are staying in Wiesbaden for the purpose of participating in seminars in accordance with Sections 5 Paragraph 2 and Section 6 Paragraph 2 of the Youth Voluntary Service Act or in further training, courses and similar events or to carry out their duties as part of the Youth Voluntary Service, for the duration of these,
- Persons up to the age of 21 who take part in political education events at institutions recognized by the Federal Agency for Civic Education, for the duration of these events.

From February 1, 2024, the following are subject to tourist contributions:

- · People who are only in the survey area to practice or train their profession,
- · People who take part in conferences, courses, courses or trade fairs,

provided they do not belong to the above-mentioned exempt groups of people.

The obligation to pay a spa fee is waived upon presentation of a medical certificate Patients' certificate for the period in which they cannot leave their accommodation, upon request freed. Furthermore, the obligation to pay can be waived upon request in cases of particular hardship The spa fee can be exempted or the spa tax can be reduced. Applications must be made in writing to State capital Wiesbaden.

All guests who are obliged to pay the spa fee will receive a spa card for the duration of their stay, which they can use to receive discounts from various partners in the city.
